E. LEVEL OF GREEK LANGUAGE KNOWLEDGE

This educational program includes **four** levels:

Level A1: This is a basic course comprised of lessons of the Greek language, History and Culture and everyday life practices (Beginners).

Course length: 125 hours

Level A2: The course comprises of two parts: Greek language course (150 h) and Greek History and Culture (25 h). Course length: 175 hours

Level B1: educational program in the Greek language (160 h) and Greek History and Culture (25 h).

Course length: 185 hours

Level B1 (for specific purposes): emphasis on understanding and producing oral speech. Greek language (170 h) and Greek History and Culture (25 h). Course length: 195 hours

F. Three-hour courses run twice (2) or three (3) times per week.
